If you choose not to include an email address when requesting assistance, we will reach out through means you have provided.

Email Communication

Under Wyoming law, e-mail addresses are public records. If you do not want your e-mail address released in response to a public records request, do not send electronic mail to this entity. Instead, contact this entity by phone or in writing.
